## community updates

Heights residents should be aware of the following current local issues that will be affected as the new Cunningham administration establishes its policies.

The protections of the **Palisades Preservation Overlay District** (aka Steep Slope Ordinance) are in danger of being lost because of a lawsuit filed against the City by a developer who is attempting to have the entire new zoning ordinance thrown out. In the meantime, the local residents have met with Planning officials to lobby for amending the Steep Slope Ordinance for better safeguards. As soon as these amendments are refined they will be presented to the community for review and approval.

The **New Neighborhood Study** is still pending. This was an attempt by the prior administration to create another redevelopment zone - this time involving the Palisade cliffs and the land below the cliffs from Hoboken Avenue north to the base of Riverview-Fisk Park. The Planning Department postponed this study in the spring until the Steep Slope Ordinance was in place but it will probably be resumed in the fall.

Of immediate concern is the **Gateway I** project in Hoboken - which will consist of two 17-story structures. It will be a mixed use development located at Marshall and First Streets - just across the Paterson Plank railroad tracks. On June 19th, the Hoboken Board of Adjustment granted the developers final subdivision approvals, along with numerous variances to accommodate the project. The project as presently approved will rise 50 -70 feet above the cliffs. Residents have reached out to Hoboken officials to review this project.
