RNA Park Fest & Flea Market Biggest Ever

The **25th Annual RNA Park Fest and Flea Market** was held on September 17th in Riverview-Fisk Park on a cool, mostly cloudy day. More than 100 vendors and community groups set up tables, 20% more than last year and hundreds of area residents came out to shop and enjoy the entertainment. This year, for the first time, we had a big stage set up and featured four Jersey City bands/performers: **Chris Roberts, The Benson Ridge Project Band, Zone** and **Silverplane Crucifix** as well as music throughout the day by **DJ Deep Creep**. Kids enjoyed free facepainting and over 30 kids participated in an art workshop run by The Distillery Gallery & Art Space where they created and designed their own book. At-Large Candidates' Forum - October 13th

It is election season again in Jersey City. RNA is joining in with a coalition of Heights community organizations and the *Jersey City Independent* to **sponsor a candidates' forum for the two openings for at-large seats on the City Council. The forum will be held on Thursday, October 13th from 7PM -9PM at the Christa McAuliffe Elementary School (P.S. 28) at 167 Hancock Avenue in Jersey City Heights.** The seventeen candidates certified to run have all been invited to participate and we expect most of them to attend. The special election will be held on November 8th to fill the two at-large seats vacated by Mariano Vega and Willie Flood.

Galaxy Recycling - Upper lot usage to be reduced

Galaxy Recycling located on New York Avenue (aka Ravine Road) has informed us that it has leased another location to park its trucks (the Recycling transfer station is NOT moving) and will greatly reduce the number of trucks and in and out of the lot along Ravine Road (at the bend) in about 60 days. This should reduce some of the noise from this local business as well as the wear and tear on Ravine Road. The Hudson Regional Health Commission has been out to visit the area after receiving noise and odor complaints but as far as we know, no violations have been issued as of publication. If you wish to lodge a formal complaint, please contact the Hudson Regional Health Commission at 201-223-1133 or email them at complaints@hudsonregionalhealth.org. It is important to note the date, time and nature of your complaint when you contact them. Messages left in the middle of the night will be reviewed the next morning.

Have flooding, blocked catch basins or Municipal Utilities issue?

At RNA's September meeting, residents of New York Avenue who have had flooding and sewage back ups, shared their troubles with Eileen Gaughan, Chairwoman of the Municipal Utilities Authority and Rich Hyatas, an MUA Chief Engineer.
